The cohabitation of government and local government in the Republic of Poland. Legal and constitutional aspects

The relations of the government (central authorities) and local government and the place of local government in the system of public authorities are becoming an increasingly frequent subject of scientific research, although still insufficiently described. The Constitution of the Republic of Poland formulates the principle of the separation of public authorities, as well as the decentralization of public power. The government and local government in Poland participate in the exercise of public authority, and also contribute to the public administration system. This forces them to broadly defined cooperation on many fields of public management. This cooperation concerns both the implementation of public tasks and the creation and implementation of public policies. These entities largely contribute to the public finance system. However, they have separate competences and self-reliance defined by law. That situation can be called a cohabitation of government and local government. It is of great systemic importance, which requires thorough examination and analysis. A special expression of this cohabitation is, i.a., the Joint Commission of the Government and Local Government which is a forum for cooperation between the government and local government in Poland.
